Leamington Music is now in its twelfth year, promoting a winter season with monthly series of string quartet and early music concerts, plus a range of other concerts, the Leamington Music Festival Weekend over the first May Bank Holiday weekend and some concerts in the summer. It also runs an Education Programme, including master-classes and workshops for schools in Warwickshire, and it sponsors the Leamington Music Prize, awarded annually to students from the Birmingham Conservatoire. Donations to the Friends of Leamington Music are used to support all of these activities. Friends have occasional special events and receive newsletters and e-mail updates. They also have priority booking for the winter programme and for the Leamington Music Festival Weekend.

Subscriptions for the 2018-19 season (valid up to 31 March 2019) are £25 for a single person or £40 for a couple.

Leamington Music's income from concert ticket sales makes up only about 50% of our total running costs and the remainder has to be generated from other sources. Consequently, additional contributions towards the Leamington Music Prize, the Education Programme and for general support are greatly appreciated.
