Leamington Music, formed in 2006, promotes a Winter Season with monthly string quartet / chamber music concerts in the Royal Pump Rooms and early music / choral concerts in St. Mary's Church, Warwick. The Leamington Music Festival is held over the first May Bank Holiday weekend and there are a range of other concerts during the year. We run an Education & Community Programme of master-classes and workshops for schools in Warwickshire. We also sponsor the Leamington Music Prize which is awarded annually to students at the Royal Birmingham Conservatoire. Donations to the Friends of Leamington Music are used to support all of these activities.
